## **Preface**

This is the common CSA and UL standard for *Hand-Held Motor-Operated Electric Tools – Safety – Part 2-20 Particular Requirements For Band Saws*. It is the first edition of CAN/CSA-C22.2 No. 60745-2-20 and the first edition of UL 60745-2-20. This standard is an adoption of IEC 60745-2-20, first edition.

This common standard was prepared by the Canadian Standards Association (CSA) and Underwriters Laboratories Inc. (UL).

This standard was reviewed by the CSA Subcommittee on Safety of Hand-Held Motor-Operated Electric Tools, under the jurisdiction of the CSA Technical Committee on Consumer and Commercial Products and the CSA Strategic Steering Committee on Requirements for Electrical Safety, and has been formally approved by the CSA Technical Committee.

This standard has been approved as a National Standard of Canada by the Standards Council of Canada (SCC).

This standard has been approved by the American National Standards Institute (ANSI) as an American National Standard.

Note: Although the intended primary application of this Standard is stated in its scope, it is important to note that it remains the responsibility of the users of the Standard to judge its suitability for their particular purpose.

Where reference is made to a specific number of samples to be tested, the specified number shall be considered a minimum quantity.

NOTE 1 When "Part 1" is mentioned in this standard, it refers to IEC 60745-1.

This part 2 supplements or modifies the corresponding clauses of IEC 60745-1, so as to convert that publication into the IEC standard: Safety requirements for band saws.

When a particular subclause of Part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. When this standard states "addition", "modification" or "replacement", the relevant text in Part 1 is to be adapted accordingly.

NOTE 2 The following numbering system is used:

- subclauses, tables and figures that are numbered starting from 101 are additional to those in Part 1;
- additional annexes are lettered AA, BB, etc.

NOTE 3 In this standard, the following print types are used:

- requirements: in roman type;
- test specifications: in italic type;
- notes: in smaller roman type.

Words in **bold** in the text are defined in Clause <u>3</u>. When a definition concerns an adjective, the adjective and the associated noun are also in bold.

With amendment 1, this Part 2 is established on the basis of the fourth edition (2006) of IEC 60745-1, Hand-held motor-operated electric tools—Safety – Part 1: General requirements.

Main changes include editorial modifications to match with the fourth edition of IEC 60745-1 and clarifications in Annex K.

## 8 Marking and instructions

This clause of part 1 is applicable except as follows:

## 8.12.1.1 Addition:

- Hold power tool by insulated gripping surfaces, when performing an operation where the cutting accessory may contact hidden wiring or its own cord. Cutting accessories contacting a "live" wire may make exposed metal parts of the power tool "live" and could give the operator an electric shock.

## 9 Protection against access to live parts

This clause of part 1 is applicable.
